CONTEST RULES

(revised 7/28/2017)

The following constitutes Contest Rules, both on and off-air on WMRF hereafter referred to as "station"

1. Once a week, the station gives away a free lunch from the Downtown OIP & Grille in Lewistown that features two (2) party packs (ribs, wings, and pizza).
2. One person will win the lunch for themselves and their co-workers.
3. Winner is selected on Thursday, receives winnings Friday.
4. To enter, you must listen to Merf Radio at 9:30am Monday through Thursday mornings to find out the day's "Party Pack Password." Then, at 2:20 each of those days, you must be caller number ten (10) with the correct password to be a qualifier for that week.
5. Every Thursday at 2:55pm, the winner of that week's Office Party will be announced on the air. The food will be delivered, barring any unusual circumstances, the following day. In the event, Merf Radio cannot deliver the winnings, the winning office may make arrangements to pick it up at the Downtown OIP & Grille.
6. An **office** may only be qualified one time per week and cannot win more than once per 30 days.
7. All STATION contests are open to any/all STATION listeners, unless otherwise specified by STATION or its affiliates.
8. Only one winner or qualifier per family or household will be allowed.
9. Winners must sign a release prior to receiving their prize.
10. All prizes, unless otherwise specified, must be picked up within 30 days of winning. STATION will not notify winners of the time remaining on their prize. It is the responsibility of the winner to claim the prize within the thirty days provided.
11. All unclaimed prizes will be forfeited.
12. STATION is at liberty to give away any unclaimed prize at the end of the thirty day grace period.
13. All major prizes will be given away by STATION . Odds of winning will depend on the number of qualified entries.

14. STATION may substitute another prize of equal value, in the event of non-availability of an announced prize.
15. In the case of a dispute over telephone lines, the decision of STATION is final.
16. In the event that two telephone lines are tied together during a phone contest, the entire phone call will be disqualified and another phone call will be taken. STATION cannot award duplicate prizes to both parties in a “tied together” situation. An example of “tied together” call may be two telephone calls originating from the same location or residence or a party line.
17. Employees of STATION , Seven Mountains Media, its advertising agencies, their affiliates, representatives, and their families or households their employees are ineligible to enter/win.
18. Prizes may be mailed at the discretion of STATION . STATION is not responsible for the failure or tardiness of prizes delivered via US Postal Service. Otherwise, prizes must be claimed in person, unless otherwise specified. Proper identification (valid driver's license, passport, state ID, military ID required).
19. In certain “unique situations”, a designated representative will be allowed to accept prize for the winner. Written authorization from the winner including representative's name, ID and a photocopy of the winner's driver's license is required. Merf will qualify what constitutes a “unique situation”.
20. STATION is not responsible for defective prizes.
21. Additions or deletions to these rules may be made at the discretion of STATION , and may be enacted at any time.
22. All winners must be 18 years of age or older.
23. STATION , its agencies, affiliates, sponsors or representatives absolve themselves of any liability, financial or otherwise, resulting from any on or off-air contests staged by STATION .
24. All contest entries become the property of STATION . Furthermore, STATION may withhold any contest materials crucial to the completion of the contest.

25. All contestants acknowledge, as a condition of entry, that STATION has a right to publicize, or broadcast the winner's name, character, likeness, voice or all matters incidental herein.
26. All prizes are non-transferable and void where prohibited by law. No cash substitution of prizes allowed.
27. Winners understand and agree that they are responsible for any and all taxes incurred on prizes received.
28. In the event that a winner chooses not to accept a prize, he or she forfeits all claim to that prize. STATION then has the right, at its discretion, to award that prize to a contest runner-up.
29. Sweepstakes/contests are open to U.S. residents only.
30. Basic contest rules and addenda are available for review during regular business hours at the STATION offices, 12 E MARKET ST, SUITE B, LEWISTOWN, PA
31. Any tie will be broken by random drawing from among the tied, qualified entries. The drawing will be conducted STATION and the results of the drawing are final.
32. The decision of STATION is final. Winner's will be notified by phone. Only one winner or qualifier per family or household every thirty (30) days.
33. Odds of winning are dependent upon the number of entries in any given week.
